## *Pre-Authorized Remittance*

By giving regularly to our church family you help nurture our congregation, support our church home, and teach our children and young people about Christ. You support people in our community through our mission and outreach programs.

Through Benevolence giving you help start new congregations, train new ministers, equip church leaders and support mission and ministry in our community and throughout the world through the Evangelical Lutheran Church in Canada and the Eastern Synod. In other words, you help make a difference!

Your gifts can also help Canadian Lutheran World Relief respond to disasters when they happen and help people around the world overcome long-term poverty.

### *We worship God with our offering*

The offering is an important part of our worship time together. Place an offering card on the offering plate as a symbol of your giving each Sunday.

- Decide the amount of your monthly or weekly offering.
- Complete the PAR authorization form and attach a cheque marked "VOID". Divide your monthly donation as you wish.
- Enclose the cheque and form in an envelope and place on the offering plate, or take to the church office.
- Withdrawals will occur on or about the 17<sup>th</sup> of each month beginning the month after your set-up procedure has been completed. You can designate, modify or cancel your donation, or change your banking information at any time, as long as you give the church office written notice.

#### **Changes may be reflected the month following receipt of the written change.**

- Our PAR Program is administered by the United Church of Canada through an arrangement with the Eastern Synod of the Evangelical Lutheran Church in Canada.

## St. Matthews (Kitchener) PAR Plan

"Each of you must give as you have made up your mind, not reluctantly or under compulsion, for God loves a cheerful giver."

Using the PAR program for your offering allows you to give intentionally, proportionally and faithfully to the church, even when you are not able to be there in person. Providing our church with a dependable flow of contributions also helps with budgeting and reduces paperwork.

It's easy. Just decide what you want to give each year and divide that amount by twelve (or decide what you want to give weekly and multiply that by 4.33, as there are 4.33 weeks in a month). Then fill out the authorization form to get started and that amount will be transferred to the church's account each month. You can place an offering card in the offering each week as a symbol of your gift.
